

RESOLUTION NO. 17-03-21

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF LAKE PARK AUTHORIZING AN AMENDMENT TO THE TOWN'S SECTION 125 CAFETERIA PLAN AUTHORIZING THE TOWN'S ELECTED OFFICIALS TO PARTICIPE IN THE TOWN EMPLOYEE'S SECTION 125 CAFETERIA PLAN; PROVIDING FOR THE TOWN'S ELECTED OFFICIALS TO PARTICIPATE IN THE PLAN UNDER A SPECIAL ENROLLMENT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Lake Park has such powers and authority as conferred upon it by the Florida Constitution and Chapter 166, Fla. Stat.; and

WHEREAS, the Town desires to amend its Section 125 Cafeteria Plan (the Plan) to include Elected Officials of the Town as employees eligible to participate in the Plan provided all other requirements of the Plan have been met; and

WHEREAS, the Town Manager recommends that the Plan be amended to include elected officials of the Town as employees eligible to participate in it; and

WHEREAS, the Town Manager recommends that the Commission adopt an Amendment to the Plan to allow Elected Officials as Town employees participate in the Plan.

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are incorporated herein.

Section 2. The Town Manager is hereby authorized and directed to execute such documents as necessary to amend the Town of Lake Park's Section 125 Cafeteria Plan.

Section 3. This Resolution shall take effect upon execution.

The foregoing Resolution was offered by Commissioner Linden, who moved its adoption. The motion was seconded by Commissioner Flaherty and upon being put to a roll call vote, the vote was as follows:


