6 X 4 Chain-link gate Green with Single sided combo lock box marine grade, key pad one sided	Install two Custom 6x4 Chain link gates with single sided combo lock box	2 EA
Barrier LED ARM 12FT	Install three Barrier Operators with 12ft LED arms	3 EA
Key Pads	Install two Wireless Key pads with Pedestals goose necks	2 EA

Responses must be clearly marked “RFQ No.103-2020, “Chain link Fence and Arm Gates installation at the Town’s Sheriff’s office” and be delivered to the Office of the Town Clerk at 535 Park Avenue, Lake Park, Florida, 33403. The deadline for submission of quotes is **Tuesday, January 28, 2020, 3:30 P.M. EST** local time.

Late quotes or quotes delivered to any other office other than the Town Clerk will not be accepted.

All bidders are advised to closely examine the Solicitation package, and to become familiar with the current condition of the Site. All proposers are further advised that the Town will not supply or sell materials to proposers in connection with submission of preparation of quotes, or any other matter, including but not limited to envelopes, labels, or tape.
