NOTICE IS HEREBY GIVEN that the Town of Lake Park, Florida (Town) is accepting sealed bids for:

LAKE PARK BASIN 9 STORMWATER OUTFALL (541 NORTHLAKE BLVD.) TOWN OF LAKE PARK, FLORIDA Invitation to Bid #106-2018

The project consists of construction of 43 l.f. of 36" diameter reinforced concrete pipe, precast drainage structure, endwall and riprap to replace a deteriorated metal pipe that serves as a stormwater outfall into the Earman River for the Town of Lake Park. The project is at the rear of the property addressed as 541 Northlake Boulevard. The project requires dewatering and excavation in excess of 15 feet within a limited work area.

The Town of Lake Park has obtained permits from the Army Corp of Engineers and the South Florida Water Management District. The project is within the corporate limits of the Village of North Palm Beach. The contractor will need to be able to apply for and obtain a permit from the Village of North Palm Beach. A bid bond and performance bond will be required as will insurance to indemnify impacted businesses/property owners and the Town of Lake Park. The Town will obtain temporary construction easements from adjacent property and business owners.

Sealed bids must be submitted in triplicate to the Office of the Town Clerk and may be deemed timely submitted if received by 11:00 a.m., May 09, 2018. The Office of the Town Clerk is located at the Town of Lake Park Town Hall, 535 Park Avenue, Lake Park, Florida 33403. Bids received by the Office of the Town Clerk after 11:00 a.m. are automatically disqualified and will be returned to the sender unopened. Receipt of a bid by any Town office, department, receptionist, or employee, other than the Clerk's Office, does not constitute "receipt" as required by this solicitation.

Project Documents: Bid documents will be available April 09, 2018, and may be obtained by calling the Town Clerk at 561.881.3311, 8:30 a.m. to 5:00 p.m., Monday through Friday, upon payment of a \$25.00 non-refundable fee for each hard copy bid set or \$15.00 for each hard copy of the project manual and CD containing the digitized plans set.

Bids shall be submitted on the form(s) provided.

Pre-Bid Conference

A non-mandatory Pre-Bid Conference is scheduled for 11:00 a.m. April 30, 2018 in the Town Hall Commission Chambers, Lake Park, Florida.

Bid Documents

Envelope containing bid must be sealed and clearly marked, "LAKE PARK BASIN 9 STORMWATER OUTFALL, No. 106-2018, Attn: Town Clerk."

All bid prices shall be guaranteed firm for 90 calendar days from May 09, 2018. Any bidder who withdraws his or her bid within 90 calendar days after May 09, 2018 shall forfeit its Bid Bond.

Bid security in the form of a Bid Bond acceptable to the Town or Certified Check or Cashier's Check made payable to the "Town of Lake Park" in an amount equal to five percent (5%) of the bid, will be required. Guaranty Bonds in the form of a Performance Bond and a Payment Bond, in an amount equal to 100% of the contract will be required. The Surety Company shall have at least the minimum rating of A-, Class VI or higher, as described in the Instruction to Bidders.

All Bids which have been timely submitted will be opened and read aloud in the Town Commission Chambers at 11:00 a.m. on May 09, 2018. Award of the contract will be made at a Town of Lake Park Regular Commission Meeting.

All bidders/proposers are advised that the Town has not authorized the use of the Town seal by individuals or entities responding to Town invitations to bid or requests for proposal, and that any such use by unauthorized persons or entities constitutes a second degree misdemeanor pursuant to Section 165.043, Florida Statutes.

All bidders/proposers are advised that the Town will not supply or sell materials to bidders in connection with submission or preparation of bids, or any other matter, including but not limited to envelopes, labels or tape.

Bidders/proposers shall demonstrate successful performance of projects of a similar magnitude, scope, value, and trade as this project.

The Town Commission reserves the right to reject any and all bids, to waive any informality in a bid and to make an award it deems to be in the best interest of the Town.
