- 2. The Centers for Disease Control and Prevention (CDC) has provided information explaining how COVID-19 is spread and that the best way to prevent illness is to avoid being exposed to the virus.
- **3.** I have read and understand the CDC's guidelines for protecting myself and others from the spread of COVID-19.
- **4.** In understand that COVID-19 may be spread by people who are not showing symptoms.
- **5.** In understand that, by renting a Town of Lake Park indoor/outdoor facility for gatherings and community events, I in exposing myself and others to the risk of becoming infected with COVID-19, which may result in illness, serious injury, permanent disability and death.

- **7.** I understand that the Town of Lake Park reserves the right to deny my request to rent an indoor/outdoor facility in order to protect the public health, safety and welfare as solely determine by the Town of Lake Park.
- **8.** I further understand that the Town of Lake Park reserves the right to interrupt and discontinue my use of indoor/outdoor facility rental for failure to comply with the COVID-19 Protocols for Facility Rentals.

I fully understand and agree that this provision regarding indemnification includes any claims based upon the actions, omissions or negligence of the Town of Lake Park, its officers, employees, agents and volunteers.
