ORDINANCE NO. 03-2022

AN ORDINANCE OF THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA REZONING SEVEN PARCELS AS SHOWN IN FIGURE 1 AND IDENTIFYING THE SPECIFIC PARCELS BY THEIR PARCEL CONTROL NUMBERS AS LISTED IN EXHIBIT "A" FROM COMMERCIAL-4 (C-4) TO CAMPUS LIGHT INDUSTRIAL AND COMMERCIAL-1 (CLIC-1); PROVIDING FOR AN AMENDMENT TO THE OFFICIAL ZONING MAP TO REFLECT THE REZONING TO CLIC-1; AND PROVIDING FOR AN EFFECTIVE DATE

- **WHEREAS**, the Town of Lake Park, Florida ("Town") is a duly constituted municipality having such power and authority conferred upon it by the Florida Constitution and Chapter 166, Florida Statutes; and
- WHEREAS, the Town has adopted a Zoning Code which establishes zoning districts and an Official Zoning Map which are codified and illustrated in Chapter 78 of the Code of Ordinances of the Town (Code); and
- WHEREAS, Josh Nichols of Schmidt Nichols ("Agent") on behalf of DG Lake Park Property Owner, LP ("Property Owner" and "Applicant"), has requested the rezoning of 10.55 acres of real properties (the Properties) from C-4 business district to the CLIC-1 district; and
- WHEREAS, Code Section 78-181 (1) sets forth procedures for rezonings of land requested by petitioners other than the Town; and
- **WHEREAS**, the Agent has complied with the application requirements set forth under 78-181 (1); and
- WHEREAS, the Town has complied with the noticing requirements set forth in Code §78-181 (3); and
- **WHEREAS**, the Properties are located as shown on the map in **Figure 1**, attached hereto and incorporated herein; and
- **WHEREAS** the Properties are legally described by their Palm Beach County property control numbers, in **Exhibit "A"**, which is attached hereto and incorporated herein; and
- WHEREAS, the Town's Planning and Zoning Board conducted a public hearing and has provided a recommendation to the Commission on the proposed rezoning; and
- WHEREAS, the Town Commission has conducted a duly noticed public hearing on the proposed rezoning.
 - NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA THAT:

Section 1. The whereas clauses are incorporated herein as the findings of fact and conclusions of law of the Town Commission.

Section 2. The Town Commission hereby rezones the Properties to CLIC-1 and directs that the Town's Official Zoning Map be amended to reflect the change of the Properties' zoning to CLIC-1 and their inclusion therein.

Section 3. This ordinance shall take effect upon execution.

Highlighted properties to be rezoned to CLIC-1 District


