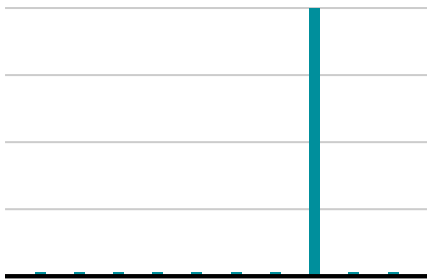

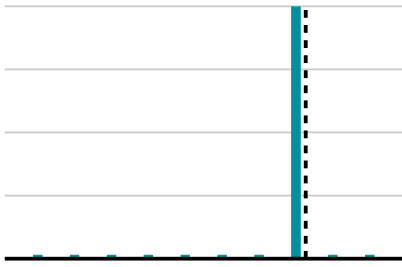

Category: Experience of Vendor



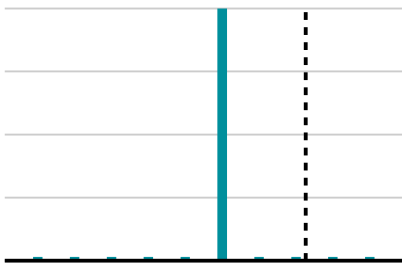
Relative Score

Category: Proposal



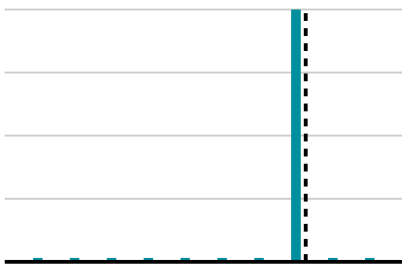
