



Pre-Proposal Grant Making Program Meeting Minutes

The Town's Grantmaking Program Pre-Applicant Conference was conducted on Friday, January 20, 2022, beginning at 2:00 p.m. Present were Grant Writer/Chief Public Information Officer Merrell Angstreich and Town Clerk Vivian Mendez.

Grant Writer/Chief Public Information Officer Merrell Angstreich welcomed everyone and reminded everyone to sign in. She explained the purpose of the meeting and reviewed the application and the process for submitting a proposal. She repeatedly stressed that an application could not be accepted by anyone other than the Town Clerk and late submittals would be returned unopened.

She accepted questions from the audience.

A member of the audience asked if Ms. Angstreich could provide an example of what was considered a donated service. Grant Writer/Chief Public Information Officer Merrell Angstreich provided the following example of a donated service: she explained that if someone volunteered to provide coaching or referee services during a grant-funded sporting event, the hours the volunteer coached or refereed would be considered a donated service.

Ms. Janice Morey, representing Holy Ground Palm Beach County, asked if a business located in Lake Park, but with a mailing address in the City of Rivera Beach, would be eligible. Grant Writer/Chief Public Information Officer Merrell Angstreich stated that she would find out if that was allowable and would call her with a response.

Grant Writer/Chief Public Information Officer Merrell Angstreich explained the review process for submitted applications and stated that a funding recommendation would be placed on a future Town Commission agenda for award. She thanked everyone for attending.
