The Non-Mandatory Pre-Bid Meeting was conducted on Tuesday, January 30, 2024 at 11:00 A.M. Present were Project Manager John Wille and Deputy Town Clerk Laura Weidgans.

Project Manager Wille went over the project dates and provided a summary of the project scope and bid documents.

Attendee Mr. Jim Beard of Total Roofing Systems had questions about an existing cap. Project Manager Wille advised that the cap may need to be retained. Mr. Beard asked what the budget is for the project. Project Manager Wille stated the budget is \$260,000. Project Manager Wille described the structure of the existing roof. Mr. Beard asked what the allowable working hours would be. Project Manager Wille stated 7am to 6pm excluding Sundays. Mr. Beard was advised to contact Project Manager Wille for access to the Library for inspection if that is what they wished to do. Mr. Beard asked if there were any known issues with the deck. Project Manager Wille stated he was not aware of any issues.

Project Manager Wille encouraged Mr. Beard to visit the site and to reach out to the Town Clerk's Office with any questions.

- Built crickets for roof pitch --- and possible the use of tapered insulation Clear-story window
- Ac equipment removal and replacement by the Town
- Building is to remain operational
