

RESOLUTION NO. 21-04-04

**A RESOLUTION OF THE TOWN OF LAKE PARK, FLORIDA,
CERTIFYING THE RESULTS OF THE RUN-OFF ELECTION
HELD ON MARCH 23, 2004 FOR TOWN COMMISSION.**

WHEREAS, the run-off election for Town Commission for the Town of Lake Park was held on Tuesday, March 23, 2004; and

WHEREAS, the duly appointed and acting clerks and inspectors of the election Board have presented to the Town Commission the certified results of said election have made their canvass of ballots as required by law; and

WHEREAS, the Town Commission did assemble together on the 7th day of April, 2004 in regular session for the purpose of certifying the election results.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA:

Section 1: Upon canvass of the election returns, as presented by the Election Board and as certified by the Town Clerk, the Town Commission hereby declares and certifies that a total of 581 electors voted in said election and that they cast ballots as follows:

(A) For the office of Group B Commission Member:

Jeff Carey 303 votes

Jeanine Longtin 278 votes

Jeff Carey having received a majority of votes cast, is hereby declared elected to said office.

(B) For the office of Group D Commission Member:

Ed Daly 297 votes

Bill Otterson 283 votes

Ed Daly having received a majority of votes cast, is hereby declared elected to said office.

Section 2. The foregoing tabulation of the votes cast is hereby certified as the results of the regular election.

Section 3. The Town Clerk is directed to send a certified copy of this resolution to the Supervisor of Elections of Palm Beach County, and to post a copy for public notice and information at two prominent places within the Town, one of which shall be the Town Hall.

Section 4. This resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Commissioner BALIUS, who moved its adoption. The motion was seconded by Commissioner LONGTIN, and upon being put to a roll call vote, the vote was as follows:
