A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA, AUTHORIZING AND DIRECTING THE MAYOR TO EXECUTE THE REDEVELOPMENT COMPETITIVE SUBGRANT AGREEMENT WITH PAARIS GOURMET, INC. dba C'EST SI BON AND TO PROVIDE \$7,896.00 IN MATCHING TOWN FUNDING; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, at its June 8, 2004 meeting, the Palm Beach County Board of County Commissioners approved the application submitted by Paaris Gourmet, Inc. dba C'est Si Bon for Round VIII Development Regions Grant Program funding; and

WHEREAS, the Town Commission has determined that it is in the best interests of the residents and citizens of the Town of Lake Park to execute the redevelopment competitive subgrant agreement with Paaris Gourmet, Inc. dba C'est Si Bon.

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF LAKE PARK:

Section 1. The foregoing whereas clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

Section 2. The Town Commission hereby authorizes the Mayor to execute the redevelopment competitive subgrant agreement with Paaris Gourmet, Inc. dba C'est Si Bon a copy of which agreement is attached hereto as Exhibit A and incorporated herein by reference.
