A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF LAKE PARK OF LAKE PARK, FLORIDA, AUTHORIZING AND DIRECTING THE MAYOR TO EXECUTE THE PROJECT AGREEMENT BETWEEN THE TOWN OF LAKE PARK AND THE FLORIDA INLAND NAVIGATION DISTRICT FOR THE LAKE SHORE PARK SEAWALL REPLACEMENT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town desires to enter into a Project Agreement with the Florida Inland Navigation District for matching funds for the replacement of the Lake Shore Park seawall; and

WHEREAS, the Town Commission has determined that it is in the best interests of the citizens of the Town to enter into a Project Agreement with the Florida Inland Navigation District.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA, THAT:

<u>Section 1</u>. The whereas clauses are hereby incorporated as true and correct as the findings of fact and conclusions of the law of the Town Commission.

Section 2. That the Mayor is hereby authorized and directed to execute the Project Agreement with the Florida Inland Navigation District for the replacement of the Lake Shore Park seawall.
