RESOLUTION NO. 04-02-05

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA AUTHORIZING THE MAYOR TO EXECUTE A UTILITY EASEMENT ON BEHALF OF THE TOWN AND IN FAVOR OF FLORIDA PUBLIC UTILITIES; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the Town of Lake Park (Town) is a municipal corporation of the State of Florida with such power and authority as has been conferred upon it by the Florida Constitution and Chapter 166, Florida Statutes; and

WHEREAS, the Town is the owner of real properties within the municipal borders of the Town; and

WHEREAS, the Town Commission has determined that it is in the best interest of the Town and Florida Public Utilities to enter into an Easement Agreement for the use of certain Town real property by Florida Public Utilities; and

WHEREAS, the Town proposes to grant a perpetual utility easement to Florida Public Utilities for the installation, maintenance and operation of gas lines and appurtenant facilities, in, on, over, across, under and through real property generally located on property within the Town; and

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF LAKE PARK:

SECTION 1.

The whereas clauses are hereby incorporated as true and correct as the findings of fact and conclusions of law of the Town Commission.

SECTION 2.

That Mayor is hereby authorized and directed to execute an Easement in favor of Florida Public Utilities for the real property legally described in Exhibit "A" and attached hereto.

SECTION 3.

This Resolution shall take effect immediately upon its adoption.
