

RESOLUTION NO. 12-03-05

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA, APPOINTING INDIVIDUALS TO SERVE AS ELECTION POLLWORKERS: CLERKS, ADVISORS, COMPUTER LAPTOP OPERATORS, AND INSPECTORS FOR THE RUNOFF ELECTION FOR THE OFFICE OF MAYOR OF THE TOWN OF LAKE PARK; AND PROVIDING AN EFFECTIVE DATE.


