

DECAL REQUIREMENT

Dear Business Owner:

All registered vehicles and/or trailer that operate within the Corporate Limits of the Town of Lake Park are required (1) to be registered as a Mobile Vendor with the Town of Lake Park, and (2) have a current Town of Lake Park identification decal placed in the lower-right corner of the vehicle's/trailer's front window (see below). Motor vehicle identification decals are now available at Town Hall. The first decal is included with your Mobile Vendor Registration at no charge; each additional decal is \$5.00 each. The decal and the Registration will expire September 30th of each year, at which time new decals for the coming year will be made available. Decals are available in the Community Development Department - Monday through Friday between 8:30am-5:00pm.
