A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA AUTHORIZING THE MAYOR TO EXECUTE A BILL OF SALE FOR THE POTABLE WATER FORCE MAIN LINES AS DESCRIBED IN EXHIBIT 1A AND 1B ATTACHED HERETO ON BEHALF OF THE TOWN AND IN FAVOR OF SEACOAST UTILITIES; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the Town of Lake Park ("Town") is a municipal corporation organized and existing under the laws of the State of Florida with such power and authority as has been conferred upon it by the Florida Constitution and Chapter 166, Florida Statutes; and

WHEREAS, the Town is the owner of certain properties within the municipal borders of the Town; and

WHEREAS, the Town Commission has determined that it is in the best interest of the Town to sell to Seacoast Utilities, the potable water and force main lines located at the Lake Park Harbor Marina as described in Exhibit 1A and Exhibit 1B attached hereto; and

WHEREAS, the Town proposes to sell to Seacoast Utilities these potable water and force main lines in consideration of the sum of Ten Dollars (\$10.00), and other good and valuable consideration; and

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF LAKE PARK:

SECTION 1.

The whereas clauses are hereby incorporated as true and correct as the findings of fact and conclusions of law of the Town Commission.

SECTION 2.

That the Mayor is hereby authorized and directed to execute a Bill of Sale in favor of Seacoast Utilities for the property legally described in "Exhibit 1A and Exhibit 1B" and attached hereto.

SECTION 3.

This Resolution shall take effect immediately upon its adoption.
