RESOLUTION NO. 28-09-05

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA ESTABLISHING THE ANNUAL, SEASONAL AND TRANSIENT RATES FOR USE OF BOAT SLIPS AT THE LAKE PARK HARBOR MARINA; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Lake Park, Florida is a duly constituted municipality having such power and authority conferred upon it by the Florida Constitution and Chapter 166, Florida Statutes; and

WHEREAS, the Town Commission has previously adopted general provisions pertaining to the use and operation of the Lake Park Harbor Marina ("Marina"); and

WHEREAS, Town staff has recommended that the Town Commission establish a rate schedule for the transient, seasonal and annual use of boat slips at the Marina; and

WHEREAS, the rate schedule adopted herein shall become effective October 1, 2005: and

WHEREAS, a copy of the proposed rate schedule for use of boat slips at the Marina is attached hereto and incorporated herein as Exhibit "A" and shall be maintained in the offices of the Town Clerk and Manager; and

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA:

SECTION 1. The foregoing "WHEREAS" clauses are hereby incorporated herein as true and correct and are hereby made a specific part of this Resolution.

SECTION 2. The rate schedule attached hereto as Exhibit "A" and incorporated herein, is hereby adopted by the Town Commission as the annual rate schedule for boat slip use at the Marina commencing on October 1, 2005 and effective until amended by a resolution of the Town Commission.

SECTION 3. This Resolution shall become effective immediately upon adoption.
