## RESOLUTION NO. 30-09-05

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA, REVISING THE TOWN PENSION PLAN FOR GENERAL EMPLOYEES TO PROVIDE FOR THE PARTICIPATION ELIGIBILITY OF THE TOWN MANAGER; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on November 4, 1998, the Town Commission of the Town of Lake Park adopted Resolution 66, 1998 establishing a pension plan administered by the Variable Annuity Life Insurance Company (hereinafter referred to as "VALIC") for Town employees not covered by other pension plans available within Town service; and

WHEREAS, employees deemed eligible to participate in the VALIC pension plan specifically excluded the Town Manager, Fire Department Employees covered under the Town of Lake Park Municipal Firefighters Retirement Fund, police officers covered under the Town of Lake Park Municipal Police Officers Retirement Fund, bond project employees, and all other employees who are covered under individual employment contracts with the Town of Lake Park; and

WHEREAS, it is desirable to remove the exclusion of the Town Manager from eligibility for participation in such plan,

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, AS FOLLOWS:

- Section 1. The whereas clauses are incorporated herein as true and correct findings of fact and conclusions of law of the Town Commission.
- Section 2. The VALIC pension plan is revised to make the Town Manager eligible for participation.
