## RESOLUTION NO. 52-09-06

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA AMENDING THE HOURS OF OPERATION FOR THE BOAT LAUNCHING RAMP AT THE LAKE PARK HARBOR MARINA AND AUTHORIZING THE MAYOR TO EXECUTE ALL NECESSARY DOCUMENTS TO REFLECT SUCH AMENDMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town of Lake Park ("Town") is a municipal corporation of the State of Florida, with such power and authority as has been conferred upon it by the Florida Constitution and Chapter 166, Florida Statutes; and

WHEREAS, the Town wishes to revise the hours of operation for the boat launching ramp at Lake Park Harbor Marina to provide that the ramps will be open from 6:00 AM until 6:00 PM daily, seven (7) days a week, except for special events and holidays in which case the operating hours shall be determined by the Town Manager in conjunction with the Marina Manager; and

WHEREAS, in addition the Town Manager and Marina Manager wish to reserve the right to adjust those hours to stay open later for special events such as holidays, fishing tournaments, etc.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF LAKE PARK:

## SECTION 1.

The whereas clauses are hereby incorporated as true and correct as the findings of fact of the Town Commission.

## SECTION 2.

The hours of operation for the boat ramp at the Lake Park Harbor Marina shall be from 6:00 AM until 6:00 PM daily, seven (7) days a week, except for special events and holidays, in which case the operating hours shall be determined by the Town Manager in conjunction with the Marina

Manager. The Mayor is authorized to execute Town documents to reflect the change in operating hours.

## **SECTION 3.**

This Resolution shall take effect immediately upon its adoption.
