

RESOLUTION NO. 18-05-11

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA, APPOINTING INDIVIDUALS TO SERVE AS ELECTION POLLWORKERS: AS CLERKS, COMPUTER LAPTOP OPERATORS, AND INSPECTORS FOR THE SPECIAL ELECTION ON TUESDAY JUNE 28, 2011 FOR THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, PALM BEACH COUNTY, FLORIDA; AND PROVIDING AN EFFECTIVE DATE.
