SEVERABILITY; AND PROVIDING FOR
AN EFFECTIVE DATE.

More specifically, the Ordinance pro-poses the following:

- Permitted Use Table amendments to include additional and revised uses which include: Brewpub; Micro brew-ery; Small and Large Brewery.
- (2) Amendments to the parking regulations to allow for more flexibility in the downtown district whereby specific parking requirements are listed and public parking spaces can also be considered in the form of a downtown master public parking plan and for the creation of the necessary parking programs associated thereto.
- (3) Creation of special provisions that would allow for sidewalk cafes and courtyards in the downtown district pursuant to certain application requirements.

If a person decides to appeal any decision made by the Town Commission with respect to any hearing, they will need a record of the proceedings and for such purpose may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
