

RESOLUTION NO. 03-01-17

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA, APPOINTING INDIVIDUALS TO SERVE AS ELECTION POLLWORKERS; AS CLERKS, INSPECTORS, AND DEPUTY FOR THE GENERAL MUNICIPAL ELECTION ON TUESDAY MARCH 14, 2017 FOR THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, PALM BEACH COUNTY, FLORIDA; AND PROVIDING AN EFFECTIVE DATE.
