RESOLUTION NO. 14-02-06 Financial Assistance Agreement.

A RESOLUTION BY THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA, AUTHORIZING AND DIRECTING THE MAYOR TO EXECUTE THE

FINANCIAL ASSISTANCE AGREEMENT BETWEEN THE TOWN OF LAKE PARK AND PALM BEACH COUNTY FOR FUNDING FOR ENGINEERING AND DESIGN OF THE IMPROVEMENTS TO PARK AVENUE BETWEEN 7TH STREET AND FEDERAL HIGHWAY; AND PROVIDING FOR AN EFFECTIVE DATE.

Town Manager Paul Carlisle explained that Palm Beach County Commissioner Karen Marcus, under the discretionary funding, is giving the Town \$160,000.00 with no matching fund to do the engineering design for Park Avenue from 7th to Federal Highway. The funds would be used to add drainage, reduce Park Avenue from two (2) lanes to one (1) lane, install decorative medians and improve the lighting. Mayor Castro stated that if the Town accepts the funds that the residents along Park Avenue should have an opportunity for public input. Town Manager Paul Carlisle stated that preliminary drawing will be done and suggested a workshop be conducted for input. Mayor Castro inquired about an RFP for this project. Town Manager Paul Carlisle stated that Calvin Giordano will do the work under their current contract with the Town.

Authorize the sale of alcohol at the Marina Grand Opening

Town Manager Paul Carlisle stated that the Marina Grand Opening date has been suggested for April 29, 2006, although the Harbor Marina Advisory Board suggested May 20, 2006. Mayor Castro stated that May is getting closer to the rainy season. Town Manager Paul Carlisle stated that a small event will be scheduled for that date which Recreation Director Dale Dougherty will coordinate. The events will include a fishing tournaments, a small band, and the sale of alcohol. Mayor Castro inquired about funds to hold this event. Town Manager Paul Carlisle stated that \$7,000.00 are available in the budget for this event. The Harbor Marina Advisory Board suggested a small fireworks display, which will require additional funds.

Town Manager Paul Carlisle stated that invitations would be sent to Palm Beach County Commissioners, representatives from the F.I.N.D., and all others that contributed to the Marina.

Town Manager Paul Carlisle stated that the plaques will not be completed by April 29, 2006, but replicas would be presented at the Grand Opening and replaced with the real plaques when they are completed.

Commissioner Balius inquired about the Harbor Marina Advisory Board suggested May for the Grand Opening. Town Manager Paul Carlisle explained that there are many fishing tournaments scheduled in April and the Harbor Marina Advisory Board saw May as a transition month before the summer season started.

Vice-Mayor Garretson

Vice-Mayor Garretson expressed his joy that Palm Beach County Commissioner voted earlier this week to have Scripps built in Jupiter. Vice-Mayor Garretson stated that he and Town Manager Paul Carlisle worked many hours with the Jupiter/Abacoa team to bring Scripps to the North County. Vice-Mayor Garretson stated that now is the time to market Lake Park, because these companies coming to work at the Scripps site are going to need affordable acres, which can be located in Lake Park behind Target. Town Manager Paul Carlisle stated that Jupiter and Palm Beach Gardens, had contacted him, to ask if Lake Park would participate in the booth they are getting at the BIO Science 2006 in Chicago from April 9-12, 2006, where the Town's will have an opportunity to market the plan to the Scientist. Town Manager Paul Carlisle stated that he would be attending and suggested that one (1) Commissioner or the Mayor should attend. The Commission choose to have either the Mayor or Commissioner Daly attend.

Mayor Castro

Mayor Castro thanked Vice-Mayor Paul Garretson and Town Manager Paul Carlisle for all their efforts on the Scripps project.

Mayor Castro explained that a Special Call meeting took place on Saturday, February 11, 2006 regarding the law suit filed against the Planning & Zoning Board on the Mariner's Key project.

Mayor Castro stated that Park Avenue looks good now that it has been repaved, as well as 2nd Street and Bayberry Drive.

Mayor Castro stated that the Wal-Mart project is moving very quickly.

Mayor Castro inquired about the gas coming back. Town Manager Paul Carlisle stated that they do not need to come back before the Commission because they agreed to all the conditions.

Mayor Castro inquired about the proposal for the Dealership at the Twin City site. Town Manager Paul Carlisle stated that it has been placed on hold for now.

Town Attorney

Town Attorney Thomas Baird stated that Code Compliance Department needs authorization to proceed with placing a lien on the O'Campo property, which is a vacant lot located on Bayberry

and 7th Court. The property owner owes about \$ 23,000.00 in Code Compliance liens. The Town Commission authorized to proceed with lien.

Town Attorney Thomas Baird stated that the Grimes property has a foreclosure action being filed.

Town Manager Paul Carlisle stated that Seacoast Utilities is conducting a hearing on March 15, 2006 at 7:00 p.m. at Palm Beach Gardens regarding a rate increase. It will be added to the March 1, 2006 Commission Meeting Agenda under presentation.
