# 1. Proposed Budget for Fiscal Year 2018/2019

Town Manager D'Agostino explained the proposed budget to the Commission. He stated that the budget team met individually with each Commissioner and the Mayor to discuss the budget. He explained that recently the Town was notified by the State that an additional \$20,000 in revenue was projected for Fiscal Year 2019. He explained that an initiative for redesigning the Town's website to be an intuitive website could be funded using these additional funds. The redesign of the Town's website would allow customers the ability to make electronic payments of various items (i.e. sanitation bills, code enforcement citations, etc.). It would also allow the public to access additional files from our system. He spoke of other ideas that could be incorporated in the future with a redesigned website.
