Code Officer Durgin reviewed Case No. 97-0032. He explained that on January 6, 2005, this case was granted a *Fine Reduction/Abatement Order* in the amount of \$7,650.00 for which Mr. Cherisme was ordered to comply by February 28, 2005. He further explained that Mr. Cherisme did not comply with the Order, and therefore he was recommending that the fine amount due be reduced to 20% or \$9,180.00 due by February 15, 2007. If Mr. Cherisme does not comply by February 15, 2007, the fine amount will revert back to the original amount of \$80,359.

The Magistrate asked Mr. Cherisme if he understood Mr. Durgin's recommendation and he replied that he did understand. Mr. Cherisme explained that the property is currently being sold and there will be no problem paying the fine by February 15, 2007.

FINDING: Based upon the testimony given, the Magistrate reduced the fine to the recommended amount of \$9,180.00, which includes previously assessed administrative costs, to be paid on or before 02/15/2007, failing which the fine will revert back to the original amount.

Code Officer Durgin reviewed Case No. 97-0032. He explained that on January 6, 2005, this case was granted a *Fine Reduction/Abatement Order* in the amount of \$6,750.00 for which Mr. Cherisme was to comply by February 28, 2005.. Mr. Durgin further explained that Mr. Cherisme did not comply with the Order at that time and therefore that he was recommending that the fine amount due be reduced to 20% of the original amount, or \$8,100.00, due by February 15, 2007. In the event Mr. Cherisme does not comply by February 15, 2007, the fine amount will revert back to the original amount of \$15,080.82.

The Magistrate asked Mr. Cherisme if he understood Mr. Durgin's recommendation and he replied that he did understand. Mr. Cherisme stated

that the property is being sold and there would not be a problem paying the fine by February 15, 2007.

FINDING: Based upon the testimony given, the Magistrate reduced the fine to the recommended amount of \$8,100.00 which includes previously assessed administrative costs, to be paid on or before 02/15/2007, failing which the fine will revert back to the original amount.

Code Officer Durgin reviewed Case Nos. 005-00481 and 05-00482. Town Attorney Karen Roselli said that although most of the violations at Venetian Isles

are now in compliance, that the Town has experienced continuous code violations at Venetian Isles, and for this reason, she feels that there should be no reduction in fine granted. She further explained that she believes it is premature for Venetian Isles to request a fine reduction because not all violations are in compliance.

Patrick Sullivan, Director of Community Development, addressed the Magistrate. He stated that there are continuing problems at this site, and although the Town is working with Venetian Isles on the matters, many issues remain unresolved. He stated that Captain Reese of the Palm Beach County Sheriff's Office has found numerous problems including the lighting, security gates, that a traffic study needs to be performed and there should be better screening procedures for the occupants of Venetian Isles. Additionally, there are problems with the laundry room door and many fire code violations, including fire extinguisher problems.

Code Officer Durgin explained that he has cited Venetian Isles for these problems and there are liens recorded on this property.

Mr. Julio Ortiz, Property Manager of Venetian Isles, addressed the Magistrate. He explained that he has been the Property Manager of Venetian Isles since October 2006 and that he has been working closely with Code Officer Durgin in order to solve these issues. Mr. Ortiz explained that some of the problems they are having are police related and that they do perform criminal background checks on their potential residents. He further explained that most of the lighting problems would be resolved next week, the laundry room door has been ordered, the exit lights have been repaired, and new fire extinguishers have been ordered. Mr. Ortiz indicated that he is working very hard to cooperate with the Town of Lake Park and the Palm Beach County Sheriff's Office to bring the property into compliance; but that it is a very difficult property and it will take additional time.

The Magistrate stated that it is clear that the issues still exist on the property. Again, Attorney Roselli indicated that the request for fine reduction is premature and suggested that they come back upon full compliance.

Magistrate Rubin explained that abatements are not allowed until the property is in full compliance and therefore, he was recommending that the case be delayed for 30 days.

Attorney Roselli suggested that Officer Durgin and Mr. Sullivan prepare a list of all violations that need to be resolved at Venetian Isles prior to the March 1, 2007, Hearing.

FINDING: Based upon the testimony given and the fact that the violations continue to exist, the Magistrate delayed the case 30 days until the March 1, 2007, Special Magistrate Hearing.

Code Officer Durgin reviewed Case No. 05-00962 & 06-10820. He explained that multiple violations were cited on this property and that the case was previously heard by the Magistrate on August 4, 2005. All violations were corrected, with the exception of the vehicle violation, for which an Affidavit of Compliance was issued on September 1, 2005. Considering that multiple violations were corrected, with the exception of the vehicle violation, Officer Durgin recommended the daily fine be reduced from \$250.00 to \$100.00 per day for 10 days of non-compliance, plus 10% interest and administrative costs, for a total amount due of \$1,378.00 to be paid by February 22, 2007.

Mrs. Lajeunesse was present but chose not to address the Magistrate.

Officer Durgin reviewed Case No. 05-01791 which involves a permit for a 15-20' gate and post across Mr. Peacock's driveway. The gate was removed 297 days after the ordered compliance date. During those 297 days of non-compliance, Mr. Peacock proceeded to construct a room addition and window alterations without a permit, for which he was cited. Officer Durgin recommended reducing the fine to 10% of the original amount, plus 10% interest and administrative costs, for a total amount of \$3,387.50, payable by March 1, 2007. If the fine is not paid by March 1, 2007, the fine will revert back to the original amount.

Mr. Peacock arrived late and addressed the Magistrate. Mr. Peacock told of his financial hardships and requested a greater fine reduction. Magistrate Rubin explained that 10% of the fine amount is the lowest that the Town can go. Mr. Peacock explained that he will be refinancing is home in the upcoming months which will provide him with the funds to pay the fine. He requested that he be given additional time. The Magistrate agreed to give him until September 30, 2007.

FINDING: Based upon the testimony given, the Magistrate ordered the fine reduction in the amount of \$3,387.50, including interest and administrative costs, payable by September 30, 2007. If the fine is not paid by September 30, 2007, the fine will revert back to the original amount.

Attorney Roselli requested that Case No. 0610912, Capital Options Group, LLC., John Conley Registered Agent is added to the agenda. Ms. Roselli explained that there are ongoing renovations at the commercial historic

building site located at 918 Park Avenue which require approval from the Historic Preservation Board to make the corrections needed to bring the property into compliance. An Order was previously entered on this Case on October 5, 2006, with a compliance date of December 5, 2006. Attorney Roselli requested to jointly move for an amendment to the Order to extend the compliance date to April 1, 2007. Attorney Roselli explained that there will not be any fines running since the compliance date is being extended. She also requested that Mr. Conley be required to pay administrative costs in the amount of \$131.75 within 24 hours of the Hearing, or February 2, 2007.

Diane Wiebert, Inspector, Palm Beach County Fire Rescue, addressed the Magistrate and explained that "Women of Dignity" is operating a halfway house which is considered to be a boarding care facility which requires a sprinkler system and fire alarm system, and they have neither. The Magistrate questioned if "Women of Dignity" is properly licensed to provide residential treatment to which Ms. Weibert responded no. Ms. Wiebert indicated that the Women of Dignity's website states that they provide onsite counseling and care for addictions. Officer Durgin clarified that they are being cited for not possessing an occupational license and for overcrowding.

FINDING: Based upon evidence and testimony given, the Magistrate found the Respondent in violation and ordered compliance on or before February 19, 2007, failing which a fine of \$250.00 per day, per violation shall accrue. The Magistrate noted that the occupational license violations are limited by statute. The Respondent was ordered to pay administrative costs in the amount of \$133.00 within 10 days of this Hearing.
