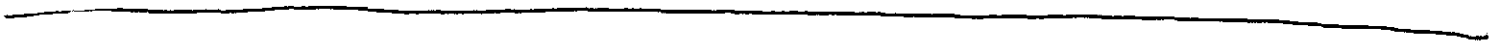

**PROCLAMATION BY THE
TOWN OF LAKE PARK, FLORIDA
IN HONOR OF WILLIAM E. BRANT**

MAY 24, 1926-JUNE 6, 2004

WHEREAS; *William E. Brant* was a long time resident and business owner in the Town of Lake Park; and

WHEREAS; in 1944, while serving in the Armed Forces of the United States of America, *William E. Brant* distinguished himself through acts of heroism, outstanding achievement, and by meritorious service and thereby was awarded a bronze star; and

WHEREAS; between 1963 and 1967, *William E. Brant* served with distinction as Mayor and Municipal Judge of the Town of Lake Park where he maintained a moral reputation that evidenced itself in his honest, honorable and fair dealings with the citizens of the Lake Park community; and

WHEREAS; throughout his tenure in office, *William E. Brant* was instrumental in the passage of several important Commission initiatives, and was renown for his local law firm, Brant and Baldwin, which is operative in the Town of Lake Park today; and

WHEREAS; by virtue of his altruistic service to the Town of Lake Park, *William E. Brant* has earned the respect and admiration of all who knew him; and

WHEREAS; *William E. Brant* passed on to his resting place, leaving behind an abundance of commendable achievements.
