Summary Explanation/Background:

At its May 21, 2003 meeting, consensus was granted by the Town Commission for the June 14, 2003, rededication of the historically restored Town Hall and the historically restored Commission Chamber, and for purchase of commemorative plaques honoring the occasion. Temporary plaques were purchased and used for June 14, 2003 dedication ceremony, while the permanent bronze plaques were ordered.

The permanent bronze plaques have arrived. Staff is seeking authorization from the Commission to have the plaque commemorating the rededication of Town Hall installed by the Public Works Department at the Park Avenue entrance on the front of the Town Hall building across from the National Historic Register plaque which is currently in place.

Staff is also seeking authorization from the Commission to have the plaque commemorating the rededication of the historically restored Commission Chamber installed by the Public Works Department on the interior rear east wall of the current Commission Chamber near the patio exit.

A total amount of \$400.00 of the overall cost for both of the bronze plaques was donated by the architect and the contractor.
