CREDIT CARD AUTHORIZATION FORM

This form is subject to the following terms and conditions and cannot be changed unless agreed to in writing by both parties.

I _____, the undersigned, am the user of the credit card hereby presented and personally authorize the Lake Park Harbor Marina (LPHM) to automatically charge my credit card listed below the 1st of each month for a dockage slip fee in the amount of \$_____, plus applicable Florida sales tax, a utility fee of \$_____, metered electrical charges, and all charges on account as well as other sums owed in connection with the use of the Marina and facilities. I hereby understand that my credit is set-up on Auto-pay for twelve (12) monthly payments and therefore waive my right to sign a credit card receipt for each payment transaction made against my credit card account for the monthly charges. This authorization shall remain effective in full force and effect for a period of one year and shall automatically renew subject to the right of cancellation by giving written notice of such intention at least thirty (30) days prior the effective date of such cancellation.

Should I decide to change my credit card for my charges, I will immediately notify LPHM in person or send written notification by certified mail/return receipt. I will immediately provide LPHM with my new credit card information so that payment is made on time, which is the 1st of each month. I hereby agree **NOT** to have my credit card company charge back (i.e. reverse) any payments on my credit card for monthly fees charged per the Dockage Agreement. _____ (initial)

I understand that LPHM hereby asserts a Maritime Lien against my vessel for any unpaid charges owed to the Marina for services rendered to my vessel. In the event that any balance owed to LPHM is not paid and the LPHM employs a third (3rd) party to collect this balance, I understand that I am liable for any and all collections fees, interest, court costs, filing fees, U. S. Marshall fees, Substitute Custodian fees or any other cost or fees related to the collection of this debt.

I hereby understand that this method of payment is extended to me as a courtesy and I hereby unconditionally and irrevocably guarantee payment and performance of the terms and conditions of this agreement.

I have looked at the dock space to be rented, and consider the space to be in excellent condition. _____ (initial)

In the event that I am acting on behalf of the owner(s), I personally guarantee payment should the owner(s) or entity fail to pay any unpaid balance regarding this vessel. _____ (initial)

Cancellation: Cancellation of payment to my credit card for the above services can only be terminated by written notice sent by certified mail/return receipt THIRTY (30) days prior to the expiration date of my dockage contract. Any alteration to the terms and conditions of this contract can only be made in writing whereby both parties agree to those alterations.
