Draft an action plan for Public Outreach Components #1 and #2.

Stormwater Policy Committee Meeting Minutes November 19, 2019

There are three (3) Public Outreach Components. In the previous meeting the Stormwater Committee addressed all three main plan components: The website, a Flood Preparedness Public Survey and Public Outreach meetings and Open Houses components. An updated ranking of these components are presented for further Outreach Plan development:

- 1) Flood Preparedness Public Survey
- 2) Public Outreach Meetings and Open Houses
- 3) Website

# 1. Flood Preparedness Public Survey

Task 1 – Finalize Public Outreach Surveys Number 1 and Number 2.

Mr. Mercado lead the discussion of the Flood Preparedness Public Survey (see Exhibit "A"). As a result of the discussion the Committee choose the following as Flood Preparedness related questions to residents:

- 1) How worried are you about flooding?
- 2) Are you aware that the Town of Lake Park participates in the National Flood Insurance Program?
- 3) Do you know what the National Flood Insurance Program is?
- 4) Which of these Flood hazarders affect you?
  - Easterly flooding
  - Coastal flooding
  - Sea Level Rise/High Tide
  - C-17 Flooding Define C-17
- 5) If you know about Flood Insurance Policy & Participation (tie the maps to addresses for flood insurance at reduce rates).

The second survey to be conducted would connect Climate Change and Flooding. The Committee wanted to:

- 1) Gauge residences knowledge of Flood Insurance.
- 2) Has the Town provided enough information about the program.
- 3) Green Infrastructure Climate Change Fact Finding.

The Committee choose the following survey questions relating to Green Infrastructure:

- 1) How well informed are you about Green Infrastructure and low impact business practices.
- 2) Are you aware that Green Infrastructure is implemented through:
  - Bio-swales
  - Bio-retention
  - Pervious pavements/rooftops
  - Rain guards

- Rain barrels
- 3) Have you ever heard of Green Infrastructure.
- 4) Do you want to know about Green Infrastructure.
- 5) Do you know how it can alleviate risks.

#### Climate Change/Infrastructure

- Do you know how Climate Change will affect the Town of Lake Park in the future.
- When do you think climate change will affect the Town of Lake Park.
- Do you think the Town of Lake Park can adapt to change.

# Task 2. Finalize mechanism for survey implementation

- SurveyMonkey (Town has a plan membership with organization)
- Seacoast Utility Bill insert
- Other

The Committee discussed options for implementation of the survey.

## 2. Public Outreach Meetings and Open Houses

Task 3. Further discussed the type and timetable of public outreach meetings (i.e., workshops, presentations).

- Bring the various POA's for a Town workshop presentation (as well as open public)
- Formalize a presentation at the next available Chamber of Commerce
- Formalize a presentation at the next available Realtors Association Meeting

The Committee discussed the possibility of a workshop after the survey has been conducted to notify the Town of what the Committee has been moving towards.

Task 4. Discuss educational material for public outreach distribution or for website (i.e. FEMA/Flooding, Green Infrastructure, etc., one-pagers, PowerPoint Presentation, etc.)

The Committee discussed the educational material and where to place the material for residents. Mr. Mercado asked Ms. Sjohulm and Mr. Young to provide cost associated with plants that could be used by residents that are good for the environment. The Committee discussed setting up an sample flower garden at Town Hall to show residents how rain barrels work and how using the correct vegetation/plants creates a green-garden.
