

Minutes Town of Lake Park, Florida Commission Workshop Wednesday, December 2, 2020, 6:00 PM

The Town Commission met for the purpose of a Workshop on Wednesday, December 2, 2020 at 6:00 p.m. Present were Mayor Michael O'Rourke, Vice-Mayor Kimberly Glas-Castro, Commissioners Erin Flaherty, John Linden, and Roger Michaud, Town Manager John O. D'Agostino, Attorney Jamie Gavigan, and Town Clerk Vivian Mendez.

Town Clerk Mendez performed the roll call and Mayor O'Rourke led the pledge of allegiance.

PRESENTATION:

1. Chapter 255 Florida Statute – Public/Private Partnership (P3) Presented by Strategic Development Initiative (SDI).

Mr. Don Delaney of Strategic Development Initiatives (SDI) presented to the Town Commission (see Exhibit "A"). He requested consensus of the Commission to allow monthly presentations and updates regarding the Public Private Partnership (P3) Consulting Services associated with the redevelopment of the Lake Park Harbor Marina. He requested to present at the January 20, 2021 Regular Commission Meeting. He tasked each Commissioner to compile a list of questions for a future open discussion related to the aforementioned redevelopment project. He explained the importance of transparency and accountability and continued his presentation of Exhibit "A". He explained that a Private Entity has the ability to submit a sealed unsolicited proposal. He explained that the proposal would remain sealed until official action occurred, thereafter; the proposal becomes a public record. He explained that Florida State Statute 255.065 "Public-Private Partnerships (P3)" permitted the Town of Lake Park to create and enter into an interim agreement with the private entity of the unsolicited proposal. He explained that several technicalities of the Statute would sunset on October 2, 2021 unless extended by the Florida Legislature. Vice-Mayor Glas-Castro asked for clarification of the negotiation period with an unsolicited proposal. Mr. Delaney explained that the negotiation period might range between 21-120 days dependent upon several contributing factors.
